

If you worked at a **Nit Noi Restaurant** as kitchen or wait staff you may seek additional money.

Does This Affect Me?

This lawsuit may affect you if you worked in the kitchen, as a waiter, busboy, food runner, or other wait staff for Nit Noi from March 31, 2008, to the present at any of these locations:

1. Royal Oaks Village: 11807 Westheimer, Suite 580, Houston, Texas 77077;
2. Midtown: 2020 Louisiana, Houston, Texas 77002;
3. Galleria Area: 4703 Richmond Avenue, Houston, Texas 77027;
4. Downtown: 301 Main Street, First Floor, Houston, Texas 77002;
5. Woodway Square 2: 6395 Woodway Drive, Houston, Texas 77057.

Or if you worked at any of these locations for Nit Noi during these periods:

6. FM 1960: 850 FM 1960 Rd West, Suite D, Houston, Texas 77090 from March 31, 2008, to February 28, 2009;
7. Dairy Ashford: 1005 Dairy Ashford, Houston, Texas 77057 from March 31, 2008, to September 30, 2009;
8. The Woodlands: 6700 Woodlands Pkwy, Suite 250, The Woodlands, Texas 77382 from March 31, 2008, to December 30, 2008.

What's This About?

Some kitchen workers and wait staff have sued Nit Noi saying that they were not paid minimum or overtime wages as required by federal law. They are seeking money for their underpaid wages over the past few years.

The Court has not decided if Nit Noi owes anything. No money is available now, nor may it ever be. You have a choice to assert your rights in this case. If you do not, you will not share in an award.

What May I Get?

If the workers win, you may get up to two times the unpaid wages that you should have received.

If the workers lose, you will get nothing.

If you join the lawsuit, the Nit Noi Workers Group's lawyers will be paid out of the award only if you win. You will owe no lawyers.

How Do I Make a Claim?

If you wish to join the lawsuit, fill out the enclosed *Notice of Consent* and return it to Nit Noi Workers' Group listed below.

It must be mailed or e-mailed by September 30, 2011.

What Are My Choices?

If you wish to join this lawsuit, mail or e-mail your *Notice of Consent* by September 30, 2011, to Nit Noi Workers' Group lawyers.

If you chose to join, you will be bound by the court's decision, whether it is favorable or unfavorable. You may have to answer questions about your claim and furnish documents.

If you do not wish to join the lawsuit, do nothing.

Nit Noi may not punish a worker who joins this lawsuit.
